I. REGISTRATION FEES & RATES

I.I - [Registration pass to CSD&M Paris](#)

II. PAYMENT

II.I - Registration pass to CSD&M Paris

The payment can be made:

- by bank transfer, following an online request of proposal that has to be validated by sending us a purchase order at contact@csdm.fr. Once received your purchase order, we will edit an invoice, validating your registration.
- by paying directly online with a credit card on our secure online payment facility (an invoice will be edited and sent automatically to your email): we highly recommend this second option.

II.II - Registration pass to CSD&M ASIA

The payment can be made:

- by bank transfer: download the registration form available on the “Registration” part of the website, fill it precisely, then send this document by email to contact@csgm-asia.net. Our team will send you back a formal invoice to be paid by bank transfer or through vendors@gov platform for governmental agencies (bank account details are provided in the form). Your registration will be confirmed once the payment received by C.E.S.A.M.E.S. Singapore
- by paying directly online with a credit card, through the “Registration” part of the website on our secure online payment facility (an invoice will be edited and arrived automatically to your email box): we highly recommend this second option.
